These chambers are platform founders and contact persons for companies that want to present themselves on the platform. The web address of the platform is www.ahk-isf.com. The service partner is the company Innoloft GmbH (Aachen). The platform is initially active for a period of at least six months.

Offers and Prices

Suppliers looking for customers in Germany and other European countries as well as buyers looking for new suppliers in the countries of the platform founders and others can register on the platform. Registered suppliers and buyers can create their company profiles on the platform.

Registration for suppliers is generally subject to a fee. The basic price for this **is 280 EUR net / six months**. The participation invoice is issued by the AHK from the supplier's country. In case of suppliers from other countries than the platform founders, the participation will be invoiced by the project coordinator (AHK Poland). Only after the payment of the participation invoice, the supplier will be sent the access data with which he can register and create his company profile.

Companies (suppliers) that are members of one of the participating AHKs register free of charge.

Buyers can register on the platform free of charge and create their company profile.

Each Chamber of Commerce Abroad is entitled to offer additional services to suppliers and buyers from their country.

Industries

The platform is exclusively focused on industrial sectors and the B2B market.
